General Location

The address of our office building, which is located in the Old Mill area just off I-215, is 6465 South 3000 East. However, the building is not actually located on 3000 East. It is in a group of buildings east of the Residence Inn on 3000 East, west of Wasatch Boulevard, and north of 6200 South.

Directions from I-215

Take I-215 to the 6200 South Exit. (Travel east on I-215 from I-15 or south on I-215 from I-80.) If you're eastbound, on I-215, stay in the 6200 South lane, not the 3000 East lanes or you'll have to merge left more quickly than might be comfortable. Travel east on 6200 South, staying in the right lane as you continue through the stop light at the 3000 East. Immediately after you pass through that intersection, look for a sign that says "Old Mill 6465" with an arrow that points to the right. Just after that sign, you'll come to a right-turn-only lane, which is only about 100 yards past the intersection. Turn right onto the one-way street heading south. Continue past the first building on your left to the parking lot on the north side of the second building on your left. It's a rock-faced building with the entry doors in the middle of its north side. Park anywhere that's convenient in that lot and enter the front door of the 6465 South building. After you enter the front doors, turn to your right and go down the hall to the front door of the office at Suite 103.

Directions from Wasatch Boulevard

Travel to the stoplight at the intersection of 6200 South and 3000 East and turn left. Then take the first left-hand turn you come to – there's a Zion's Bank just past the turn on the southeast corner of that intersection. Just after you turn left, take your next left and travel up the hill. Directly in front of you will be a tall office building. Just before you get to it, turn left and travel north through the parking lot until you pass the second building on your right. It's a rock-faced building that looks different than the ones on either side of it. Turn right into the parking lot just past and north of the second building. The entry doors are in the middle of the building on its north side. Park anywhere that's convenient in that lot and enter the front door of the 6465 South building. After you enter the front doors, turn to your right and go down the hall to the front door of the office at Suite 103.
